Frank "Tick" Coleman Leads Effort to Bring Football Back to Lincoln U.

When Lincoln University thought about bringing football back after nearly 50 years, Frank "Tick" Coleman, a member of the school's class of 1935, was one of its biggest supporters. At 96, Coleman is one of Lincoln's oldest alums. He also played football for the historically black college in Lincoln University, Penn., about 50 miles outside Philadelphia. Coleman, now a well-known community leader in Philadelphia, played quarterback for the Lions from 1931 to 1935. Other notables who played football for Lincoln include Hall of Fame baseball player Monte Irvin, who played in 1939, and Robert "Whirlwind" Johnson, also known as the godfather of black tennis, who played in 1924. And although it's been 73 years since Coleman put on a uniform, he still remembers the glory days of wearing the orange and blue.

"College football brought a lot of enthusiasm to the campus," Coleman said. "The Lincoln-Howard game was a real black college football classic. Everybody looked forward to that game. It was a big rivalry. There were some great players who played during that time. We had some big crowds at the games. It's good to see all that excitement coming back."

Lincoln will revive its program after 48 years on Aug. 30 against George Mason. The Lions haven't suited up

since their 1960 matchup with Virginia Union. In 1912, Lincoln was one of the founding members of the Central Intercollegiate Athletic Association, the oldest black college conference in the country. The team's all-time record is 163-166-7, according to the school. It won CIAA championships in 1918, 1919 and 1924.

"We'll be playing a Division II schedule," Coleman said. "It will take us a while to get to that level. But the potential is there. We're playing a lot of CIAA schools like Fayetteville State, Virginia State, Shaw University and others. They have a lot of graduates in the Philadelphia area.

"This is going to help increase student enrollment. It will create opportunities for our student-athletes. In addition to football, we'll have a marching band. It's just a great thing for the university as well as the alumni." Coleman grew up in blue-collar South Philadelphia in the 1920s. In middle school, he joined the Boy Scouts and gradually climbed the ladder in the scouting organization to the rank of Eagle Scout, which is the most outstanding honor in scouting. He is currently one of the oldest Eagle Scouts in the nation.

Coleman used sports, community service and education to make a better life for himself, as well as others. After graduating from Lincoln University in 1935 and receiving a master's degree from the Penn School of Social Work in 1959, Coleman spent 32 years as an educator for the School District of Philadelphia. After retiring in 1981, he participated in a number of Lincoln University functions -- such as homecoming, sports banquets, alumni weekends and graduations -- leading the singing of the school's alma mater at many of them. Coleman served as director of alumni relations at Lincoln from 1981 to 1988 and also spent 10 years as an alumni representative on Lincoln's board of trustees.

"He has been a strong representative of Lincoln University for many, many years," said Ivory Nelson, president of Lincoln University. "He's been a supporter of the university. He does everything to assist

students in coming to the university. We call him 'Mr. Lincoln.'"

Coleman is widely recognized as one of the school's most prestigious alumni.

For the past six years, the alumni have hosted the annual Dr. Frank "Tick" Coleman Awards Luncheon. The event celebrates outstanding alumni achievements and raises money for student scholarships.

"We have some great young people out here," Coleman said. "I think the kids have a lot of potential. Obviously, things are much different today than when I was coming up. But I've spent most of my life helping young people succeed. That gives me a lot of pleasure. I'm really proud of these kids who have gone to Lincoln.


This will be a historic event. And when you talk about history, Coleman has been a real pioneer. He was the first black quarterback to play at Philadelphia's Central High School. He guided the team to two consecutive Philadelphia Public League championships (1929, '30).

Four years ago, Central High named him to the school's athletic honor roll for his achievements on the field. During the ceremony, he talked about his success at Central and about having the opportunity to play football at Lincoln. Coleman also offered words of encouragement and inspiration, and stressed the importance of going on to higher education to more than 150 students.

"He's really an amazing man," said O.J. Abanish, Lincoln's football coach. "He's very knowledgeable. He has a great memory. Dr. Coleman is a big part of the school's history. He played football here. He's given us a lot of support. He has done so much over the years."

Ted Greer Elected Omega Life Membership Foundation Chairman

At the last Omega Life Membership Foundation Annual Meeting in Birmingham, Alabama, Brother Ted Greer, the current Second Region Director, was elected **Chairman of the Board** of OLFM. Ted at the age of twenty three (LM242) along with his brothers the late Dr. Tee Stewart Greer Jr, William Floyd Greer and a cousin the late Crandell McLeod all became Life Members. The Second Region under his leadership continues to grow. During the leadership of the District Representative three years ago Gregg Ackles the Life Membership Meeting was expanded to the luncheon format to accommodate over 100 Brothers. Each year brothers were treated to outstanding speakers and meeting. The Second Region continues to grow with the great cooperation of the Second District Life Membership Committee which works very close with Brother Greer.

Ted's major goals and focus is to improve the relationship with our International leadership and to continue to give back to Omega Psi Phi thru grants and scholarships. He also wants to continue to grow the endowment,

through increase membership and fund raising programs.

Ted is originally from Miami, Florida. He attended public schools starting at Booker T. Washington High Nursery School and finishing at Miami Central High School. In 1962 Ted was one of six students to integrate public high schools in the state of Florida. At Miami Central he was an outstanding scholar, athlete and student leader. After graduation he attended Lowell Technological Institute (now University of Massachusetts – Lowell). In 1969 he became only the second Black in the United States to receive a Degree in Plastics Engineering.

In the spring of 1967 he was initiated into Gamma Chapter in Boston, Massachusetts, ironically the same night as his best friend from Miami, John Marks, who was on the charter line at Florida State and the current mayor of Tallahassee, Florida. In his senior year Ted became the Basileus of Gamma Chapter, becoming apart of a family legacy where his brother Tee was Basileus of Psi chapter at Morehouse and his brother William Floyd was Basileus of Rho Psi Chapter at Tennessee State. Ted also served as Basileus of Nu Upsilon in Wilmington and Iota Xi in New York.

In 1975 Brother Greer became the youngest District Representative in the history of the Second District. While on the Supreme Council he proposed and engineered a program to have chapters represented at the conclave according to membership size. He also drove to have the talent Hunt to include other categories other than classical music (the second District pio-

neered this idea). As District Representative he expanded the Corridor Representatives to have Deputy Corridor Representative. During his two years as District Representative he chartered a great amount of undergraduate chapters in Maryland, New Jersey and Pennsylvania.

More than twenty years ago, Brother Greer was one of twelve brothers who were charter members of the Omega Psi Phi Fraternity Credit Union. The credit union was started with a \$5000 investment deposit by the Second District. Ted spent many years and continues to serve on the Board of the Credit Union. Ted has been Chairman of the Board and marketing chairman where he created "Loans for Life" a program where brothers could obtain their Life Memberships immediately by borrowing the fee from the Credit Union.

Ted had a very successful 32 year career with the DuPont Company working in a variety of Sales and Marketing Positions in Wilmington, Chicago, New York and Toronto. Currently he is a Sales Manager with American Income Life the world's largest provider of benefits to labor Unions, Credit Union and Association families.

Bother Greer has two daughters Dr. Florencia Greer- Polite and Dr. Christina Greer-Roberts. Florencia is an OBGyn in New York City, and Christina is a Political Science Professor at Smith College and will teach at Fordham University in 2009. He also has a two year old granddaughter Gabrielle Lynn Polite in New York.

60th Second District Conference A Mighty Success As Leadership Baton Passed On To New Team

Several awards were presented during the Founder's Banquet on Saturday, May 3. Among those honored was Gamma Pi chapter's (Prince George's County, Md.) Bro. Roland Byrd, who restarted and currently heads the chapter's very successful Project ENRICH college preparatory program. He was honored with the Second District Founder's Award. At the chapter level, Epsilon chapter of New York was named Second District Graduate Chapter of the Year.

Already, Brothers are looking ahead to next year's 61st District Conference, scheduled for May 1-3, 2009 in White Plains, New York.

Gamma Pi Health Fair and Blood Drive

African Americans are unfortunately found to be close to if not at the very bottom when it comes to many health indicators. From heart disease to stroke to cancer and diabetes, the statistics tell a story of tremendous disparities in health care quality and access and lower life expectancy when African American are compared to the general population. Seizing the reins in true Omega fashion, the Gamma Pi chapter of Omega Psi Phi Fraternity recently helped educate members of the Prince George's County community about the "keys to good health" during a Health Fair and Blood Drive held June 28.

The Charles R. Drew Memorial Health Fair and Blood Drive was held at the Columbia Park/Kentland Community Center in Landover. Hundreds of persons

from the local community showed up throughout the day to give blood at the on-site bloodmobile, and to take advantage of a variety of health screenings that checked for cholesterol, glucose, diabetes, stroke, vision and hypertension among other conditions. A number of people received HIV screenings. All of the conditions mentioned above impact African Americans more harshly than other populations.

"A lot of times, we take for granted that we have life. But if we keep doing what we're doing and not taking care of ourselves, it (life) can be a temporary condition," said Eddie Epps, a member of the chapter and co-chairman of the Social Action Committee which sponsored the blood drive and health fair. Chapter member Dr. Lester Miles also spearheaded the event.

A long list of community-based health advocates assisted Gamma Pi in conducting the health screenings. Those partner organizations included Landover Area Revitalization Coalition (LARC), Prince George's Health and Human Services, Bowie State University Community Outreach, Kentland Civic Association, Lions Club, Kentland Recreation Council, the Yoruba Alliance, Lifeline, Inc., the American Red Cross Blood Mobile, RTIP Foundation, Pfizer, Howard University Sickle Cell Center and Prince George's Hospice Care.

Gamma Pi was founded in Prince George's County in 1973 and was named Graduate Chapter of the Year for 2003, 2005 and 2006.

Lambda Gamma Gamma- Mentoring Adolescent Males at RICA

Cheltenham , Maryland - The brothers of Lambda Gamma Gamma have proven to be very active in Prince George's county in support of the Regional Institute for Children and Adolescents (RICA) of the Southern Maryland program. The RICA-Southern Maryland program is a coeducational multidisciplinary program for middle and high school adolescents with emotional problems and is one of the chapter's key social action programs. The program is family oriented and community-based. RICA focuses on the strengths and abilities of adolescents and their families serving adolescents from Calvert, Charles, Prince George's and St. Mary's Counties in Maryland. Moreover, RICA helps young adults solve challenges in the home, in school and in their communities. The brothers of LGG hosts monthly sessions with the adolescent youth (young males between the ages of 12 and 17) to discuss issues such as de-

cision making, academics and scholarship, responsibility, men's health and job interview training among the many other topics designed to provide valuable information and **UPLIFT** of the young men.

The chapter's RICA committee, chaired by Bro. Antonio Ferguson recently coordinated a college campus visit to Bowie State University. Bro. Damon Wilson, assistant coach to the Bowie State Football Team, along with several players (including neophyte Bro. Joseph Embree, Epsilon Sigma 2008) coordinated the visit and discussed topics with the youth such as academic requirements, sports eligibility and campus life. The players emphasized that students must achieve a healthy balance in all aspects of college life and that maintaining academic standards in order to remain eligible to participate in athletic programs on the collegiate level is paramount. The students were given a tour of the campus and dined with the play-

ers and staff at lunch in the student cafeteria.

The chapter supported the RICA program for nearly a decade until the facility announced that it would be closing in June 2008 due to lack of funding from the state of Maryland. Bro. Ferguson states, "The program was positive in every aspect and provided a level of support that the youth in the program needed. The hosting forums and open floor discussions with the youth provided a conduit to communicate and to discover and isolate social and behavioral problems. It also provided them with hope and the opportunity to change their current behavior".

The chapter conducted its final sessions and forums in April and May discussing critical thinking and decision making. LGG is honored to have had the opportunity to give back to the community and to provide **UPLIFT** through the RICA program.

On Saturday August 2, 2008 LGG sponsored the "Kids Day at the Nationals" outing. Bro. Victor Gee lead the outing with help from over 30 brothers. Over 80 kids participated in the event. The youth activity is an attempt to expose underprivileged kids to aspects of society that they would not otherwise be exposed.

The committee created an atmosphere of fun and friendship between kids from different walks of life in the Washington metropolitan area. All 3 areas of Lambda Gamma Gamma chapter were represented, area 1 (Maryland) was represented by The Greater Mount Nebo Church, area 2 (Washington, DC) was represented by the James Creek Resident Council, Inc. housing projects which are within walking distance to the stadium, and area 3 (Northern Virginia) was represented by the Springfield Youth Club. LGG provided snacks, gold and

The Penn-Jersey Region has been dedicated to increasing the blood donations in the Black community to support Sickle Cell patients' blood transfusion needs. Sickle Cell Disease is an inherited blood disorder that causes lung tissue and organ damage, strokes and terrible pain.

People with Sickle Cell Disease have red blood cells that are stiff and distorted in shape (like a sickle) and sometimes block small blood vessels. It is

estimated that over 70,000 Americans have the disease. Ninety percent of all Sickle Cell Disease patients in the United States occur in people of African Decent. There is no cure for Sickle Cell Disease, however we can manage the disease effectively through blood transfusions.

Since 1997, the Penn-Jersey Region has had a Sickle Cell Donor program where African American or Black blood donors are asked to designate their blood donation to patients with Sickle Cell Disease with a "Blue Tag".

Within the Penn-Jersey Mu Omega (Philadelphia, PA), Epsilon Pi (Chester, PA) and Zeta Iota Iota (Oxford, PA), has assisted the American Red Cross and Sickle Cell Anemia Association in accomplishing their mission of providing life saving blood products to patients in particular those with Sickle Cell Disease by collecting over 500 units of blood.

In honor of the chapters accomplishments, the organizations presented the 2nd District and each chapter with the inaugural American Red Cross Penn-Jersey Region Sickle Cell Program Partnership Award.

The rock-solid chain of Omega Psi Phi brotherhood that is emblematic in Gamma Pi chapter lost a link in its armor recently when Brother Frederick Nims, Jr., a distinguished “50-year Brother,” was called home to Omega chapter. Brother Nims died peacefully on August 12 at a local hospice where he was taken at the tail end of a tough battle with cancer.

Brother Nims transitioned to Omega chapter a little more than a day after a large contingent of Brothers from Gamma Pi visited with him at the hospice. More than 30 Brothers strong showed up at the Capital Hospice in Arlington to pay their respects to Brother Nims and his family on Sunday, August 10. During a visit of about one hour, Brothers gathered at his bedside and quietly fellowship with family and with each other. The highlight of the visit was a subdued version of “Omega Dear,” sang by the Brothers while encircling Brother Nims’ hospital bed, hoping

to “rally” him from his condition, but also being prepared in case that was to be the last visit with him “on this side,” as it unfortunately turned out to be. Gamma Pi Brothers will remember Brother Nims as a man for all seasons that deftly crossed generational lines and displayed true Omega spirit by embracing the story and personality of every Brother he came in contact with. He turned no one away and treated all Brothers with respect. He was the epitome of dignity and grace.

In his late 70s in terms of earthly years, Brother Nims was young in “Omega Years” and young at heart. The question was never whether Brother Nims could keep up with younger Brothers, but whether they could keep up with him. In true Omega fashion befitting a “Que’s Que,” he easily and thoroughly shared his wisdom, enthusiasm and vast knowledge with Brothers who spanned every generation along the spectrum of age and every level along the spectrum of Omega membership, from neophytes to other very senior Brothers like himself. He cared deeply about the Fraternity and the Four Cardinal Principles and was an exemplary, active and fully engaged member up until his death.

“Never again will we, the Brothers who were in the circle, be able to sing “...And when we say our last goodbye, we will love Omega Psi Phi” without thinking of this shining example of Brotherhood,” recalled Brother Thaddeus Turner, who was very close to Brother Nims and worked with wife Linda and other members of the Nims

family to organize the hospice visit.

Brothers were informed during the visit with Brother Nims that he was able to hear them, but was unable to respond because of the medication he was under. So, while he appeared physically to be “out of it,” he was actually taking in Brothers’ encouraging whispers in his ear, the squeezing of his hands, rubbing of his shoulders and the melodic strains of “Omega Dear.”

For the Brothers who visited with Brother Nims, it was a touching scene that underscores the true depth of Brotherhood that describes Omega Psi Phi Fraternity, Inc. It is, Brothers were reminded during these moments, much more than people see or can even fathom looking at the Fraternity from the outside.

Brother Nims was sent home to the Supreme Basileus with a beautiful Omega Service attended by more than 80 Brothers as well as a fitting funeral tribute led by his private family and his church family on Saturday, August 16, at the Fort Foote Baptist Church in Oxon Hill, Maryland. Ironically, that date happened to be his 77th birthday. He will forever be missed and remembered as a man who truly lived and imparted the Four Cardinal Principles. Every Omega man who ever came in contact with him is a better man for having known him.

Bro. Johnie E. Harris (Delta Omega, 1960) crossed into Omega Chapter on June 19, 2008. He was born July 26, 1932 to Ernest C. and Ruth T. His career spanned 27 years in Montgomery County before he retired only to find himself once again serving the interests of scholarship as he returned as a principal in Alexandria, VA where he served 6 years before retiring the second time. And even then, Bro. Harris' lifelong commitment to scholarship found him advancing the cause of uplift when he stepped in as the Executive Director and later as the Specials Assistant for the *George B. Thomas Sr. Learning Academy, Inc.* (GBTLA), and also served as a member of the GBTLA Board of Directors.

Bro. Harris was a charter member of Mu Nu Chapter, Montgomery County, MD, which he helped found in 1970. During his 48 years of dedicated serve to Omega Psi Phi, he served as the Mu Nu Chapter Vice Basileus (1971-73) and Basileus (1973-**), as the Second District Scholarship Chairman ((1975-90) and District Marshall (1989), and as Omega's National Scholarship Committee Chairman (1988-94) and National History Committee Chairman (1994-98 & 2002-06). Wilmington, DE. May 2008 Under the leadership of Bro. Ronald Cephas, Social Actions Chairman, Nu Upsilon has conducted more than 10 Social Actions projects throughout the 2007 – 2008 fraternal year. Two of these projects are new and have focused on two of our deserving constituents – our senior citizens and our teens.

On May 17, 2008, brothers of Nu Upsilon joined forces with members of the Wilmington (DE) Alumnae Chapter of Delta Sigma Theta Sorority, Inc. (DST) to serve as facilitators for Junior Achievement's Finance Park Program (JAFPP).

Any teen who was being employed by the City of Wilmington's (DE) Summer Employment Youth Program was required to attend one of eight sessions, three hours each, of JAFPP, to learn about budgeting and finance. The teens were divided into groups of 5 – 7, and each student was given a scenario that included a specified salary, expenses that had to be paid (i.e., car note and insurance; mortgage/rent; food; clothing; en-

tertainment; gasoline; utilities; child care; etc.), and a family structure (i.e., single, with or without children; married, with or without children).

Additionally, randomly selected teens were provided with unforeseen occurrences or extra salaries through employer bonuses or part-time employment, child support, or alimony. It was the responsibilities of the brothers of Nu Upsilon and the sorors of DST to provide guidance to the young people about how to stay within their budgets based on their total household income and situations.

This activity was a “reality check” for most of the teenagers, as many of them realized the responsibilities that come along with being a responsible adult. A couple of the young ladies and gentlemen made comments like, “I need to get rid of her,” meaning his wife and “I won't have any money to go to the movies if I pay all of these bills!”

When all was said and done, the brothers of Nu Upsilon and the sorors of DST thoroughly enjoyed the experience and opportunity, and commented that this would be a good activity for

many adults!

The second collaborative effort in which the brothers of Nu Upsilon participated and coordinated was a Luncheon for Senior Citizens and Adults with Disabilities who reside in the Terry Apartments of Wilmington, DE.

In conjunction with the Black Butterflies, a sisterhood organization of Wilmington, DE and Philadelphia, PA, Nu Upsilon made and served 45 seniors and adults with disabilities a spaghetti and lasagna lunch, with garden salad, cool drinks, and a variety of desserts on September 13, 2008.


